#### Description of Necessary First Aid Measures

### Section 5. Fire Fighting Measures

### Section 5. Fire Fighting Measures

#### Protection of Firefighters:

##### For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation and inhalation of sprays, mists, vapors and gases. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

##### For Emergency Responders:

If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For Non-Emergency Personnel".

##### Environmental Precautions:

### Section 6. Accidental Release Measures

#### Small Spill:

Contain and collect spillage with a dry, non-combustible absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.

#### Large Spill:

### Section 7. Handling and Storage

#### Precautions:

Product is air/moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

#### Protective Measures:

Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

#### General Occupational Hygiene:

**Safe Storage Conditions (cont.):** Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

### Section 8. Exposure Controls/Personal Protection

**Introductory Remarks:** These recommendations provide general guidance for handling this product.
