### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

### Section 4. First Aid Measures

**Ingestion:** Call a physician or POISON CONTROL CENTER immediately. Rinse mouth. Do NOT induce vomiting. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

#### Most Important Symptoms/Effects, Acute And Delayed Potential Acute Health Effects

**Eye Contact:** Symptoms may include stinging, tearing, and redness.

**Inhalation:** Serious effects on the lungs may include asthma, pneumonia and wheezing. Inhalation may cause an irritation of the respiratory organs of sensitive persons resulting in obstruction of airways. There are references in literature associating cobalt with interstitial fibrosis, a disease that can be fatal.

**Skin Contact:** May produce irritation. Repeated exposure may cause allergic dermatitis. May cause cross sensitivity to Chromium and Nickel.

**Ingestion:** Diarrhea and vomiting may occur. Ingestion of significant amounts of cobalt containing compounds has been reported to have potential for causing blood, heart, thyroid and pancreatic damage.

#### Indication of Immediate Medical Attention and Special Treatment Needed, If Necessary

**Notes to Physician:** Treat symptomatically.

**Specific Treatments:** No specific treatment.

**Protection of First Responders:** No action taken shall be taken involving any personal risk without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation.

#### Engineering Controls:

#### Individual Protection Measures

##### **Hygiene Measures:**

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not inhale gases/fumes/vapors. Avoid contact with eyes and skin. 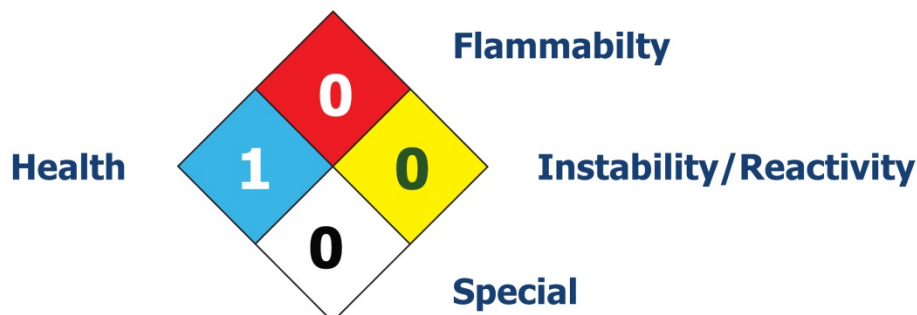
