There are references in literature associating cobalt with interstitial fibrosis, a disease that can be fatal.
- Skin Contact:** May produce irritation. Repeated exposure may cause allergic dermatitis. May cause cross sensitivity to Chromium and Nickel.
- Ingestion:** Diarrhea and vomiting may occur. Ingestion of significant amounts of cobalt containing compounds has been reported to have potential for causing blood, heart, thyroid and pancreatic damage.

Section 8. Exposure Controls/Personal Protection

Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Environmental Exposure Controls:

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. 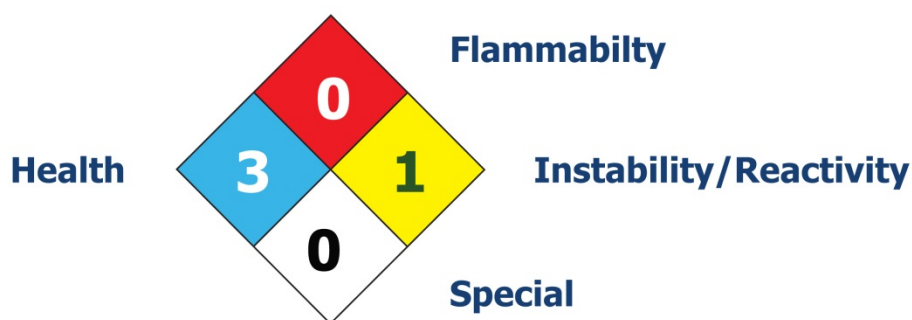
