Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

Eye Contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process. Call a POISON CENTER or doctor/physician immediately.

Skin Contact: Remove all contaminated clothing and shoes. Wash off contaminated skin with soap and plenty of water. Call a POISON CENTER or doctor/physician immediately.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Call a POISON CENTER or doctor/physician immediately.

Ingestion: Do NOT induce vomiting. Rinse mouth. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. Call a POISON CENTER or doctor/physician immediately.

Most Important Symptoms/Effects, Acute and Delayed Potential Acute Health Effects

Eye Contact: Symptoms may include stinging, tearing, redness, swelling and blurred vision.

Inhalation: Product may be irritating to respiratory system. Symptoms may include coughing, sneezing with phlegm production, sore throat, nausea, headache, vomiting.

- Skin Contact:** Symptoms may include an itching or burning sensation, reddening, swelling and blistering with tissue necrosis.
- Ingestion:** Product may be expected to be irritating to mucous membranes. Symptoms may include cramping, localized pain, headache, nausea and vomiting.

Indication of Immediate Medical Attention and Special Treatment Needed, If Necessary

Notes to Physician: Hydrofluoric (HF) acid burns require immediate and specialized first aid and medical treatment. Symptoms may be delayed up to 24 hours depending on the concentration of HF. After decontamination with water, further damage can occur due to penetration/absorption of the fluoride ion. Treatment should be directed toward binding the fluoride ion as well as the effects of exposure. Skin exposures can be treated with a 2.5% calcium gluconate gel repeated until burning ceases. More serious skin exposures may require subcutaneous calcium gluconate except for digital areas unless the physician is experienced in this technique, due to the potential for tissue injury from increased pressure. Absorption can readily occur through the subungual areas and should be considered when undergoing decontamination. Prevention of absorption of the fluoride ion in cases of ingestion can be obtained by giving milk, chewable calcium carbonate tablets or Milk of Magnesia to conscious victims. Conditions such as hypocalcemia, hypomagnesemia and cardiac arrhythmias should be monitored for, since they can occur after exposure.

Specific Treatments: See Notes to Physician above.

Protection of First Responders: No action taken shall be taken involving any personal risk without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation.

Section 5. Fire Fighting Measures

Protection of Firefighters:

Do not touch or walk through spilled material. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

For Emergency Responders:

Environmental Precautions:

Section 7. Handling and Storage

Precautions:

Product is air/moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Protective Measures:

Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing dusts and aerosols. Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

General Occupational Hygiene:

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking or smoking. Keep container tightly closed and sealed until ready for use. Store locked up.

Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Environmental Exposure Controls:

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

Hygiene Measures:

Hand Protection:

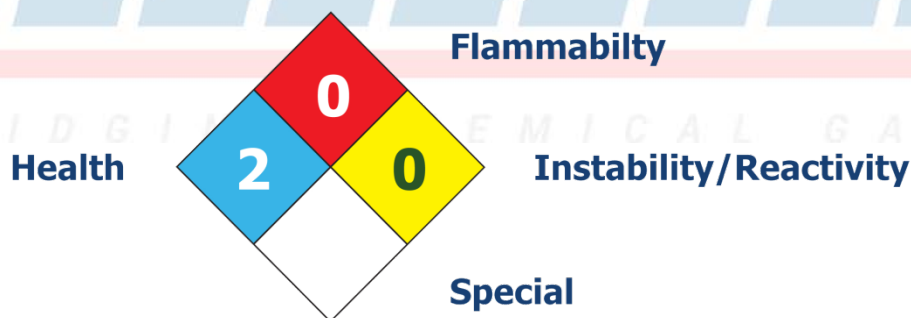
