#### Description of Necessary First Aid Measures

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. 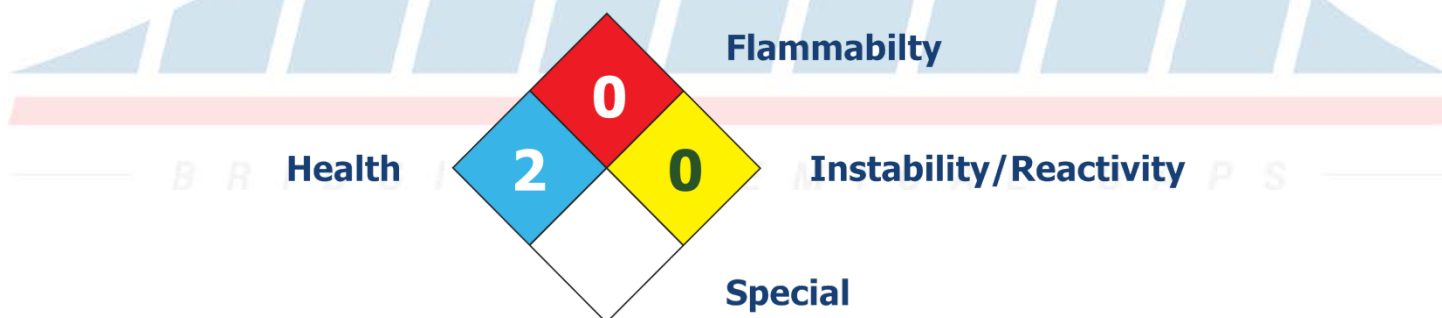
