Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. If unconscious, place in recovery position and get medical help immediately. Maintain an open airway. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid the formation and inhalation of dusts, aerosols, vapors and gases.

Section 6. Accidental Release Measures

For Emergency Responders:

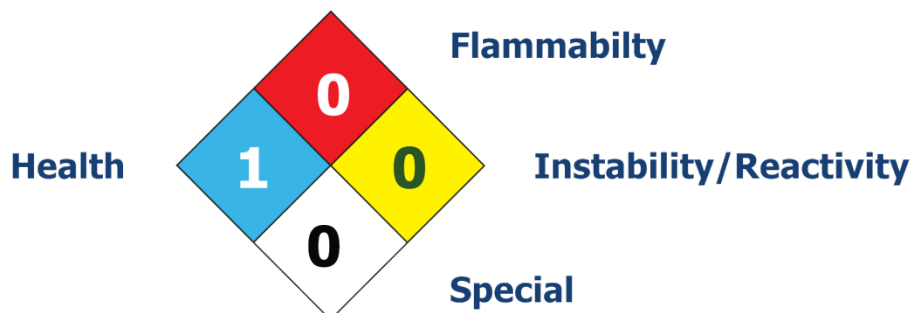
