#### Description of Necessary First Aid Measures

**Unusual Fire and Explosion Hazards:** This material reacts slowly with water and compounds containing active hydrogen such as alcohols and acids to produce t-butanol. Product runoff to sewer may create a fire or explosion hazard. T-butanol vapor/gas is heavier than air and will spread along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to an ignition source and flashback.

**Product of Combustion:** Decomposition products include carbon oxides (CO, CO<sub>2</sub>) and iron oxide.

**Protection of Firefighters:** Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid breathing dusts, aerosols, vapors and gases. ### Section 6. Accidental Release Measures

#### Personal Precautions, Protective Equipment and Emergency Procedures

**For Non-emergency Personnel:** No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. #### Methods for Containment

##### **Large Spill:**

Eliminate all ignition sources. Move containers from spill area if safe to do so. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Avoid contact with water/moisture and the creation/inhalation of dusts and aerosols. Use spark-proof tools and explosion-proof equipment. Dispose of via a licensed waste disposal contractor. ### Section 7. Handling and Storage

**Precautions:**
