Section 4. First Aid Measures

Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately if symptoms develop or if you feel unwell. Show this safety data sheet to the doctor in attendance.
- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Seek medical attention if eye irritation develops and persists.
- Skin Contact:** Take off contaminated clothing and shoes immediately. Wash off contaminated skin with soap and plenty of water. Seek medical attention if irritation develops and persists, if symptoms develop or if you feel unwell.

If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Loosen tight clothing such as a collar, tie, belt or waistband. Call a physician or POISON CONTROL CENTER if symptoms develop or if you feel unwell.
- Ingestion:** Rinse mouth. Do NOT induce vomiting. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Call a physician or POISON CONTROL CENTER if symptoms develop or if you feel unwell.

Most Important Symptoms/Effects, Acute and Delayed Potential Acute Health Effects

- General:** Conditions such as hypocalcemia, hypomagnesemia, and cardiac arrhythmias should be monitored for, since they can occur after exposure.
- Eye Contact:** Symptoms may include stinging, tearing, redness, swelling and blurred vision.
- Inhalation:** Product may be irritating to respiratory system. Symptoms may include coughing, sneezing with phlegm production, sore throat, nausea, headache, vomiting.
- Skin Contact:** Symptoms may include an itching or burning sensation, reddening, swelling and blistering with tissue necrosis.
- Ingestion:** Product may be expected to be irritating to mucous membranes. Symptoms may include cramping, localized pain, headache, nausea and vomiting.

Specific Treatments (cont.):

Symptoms may be delayed up to 24 hours depending on the concentration of HF. After decontamination with water, further damage can occur due to penetration / absorption of the fluoride ion. Treatment should be directed towards binding the fluoride ion as well as the effects of exposure. Skin exposures can be treated with a 2.5% calcium gluconate gel repeated until burning ceases. More serious skin exposures may require subcutaneous calcium gluconate except for digital areas due to the potential for tissue injury from increased pressure. Absorption can readily occur through the subungual areas and should be considered when undergoing decontamination. Prevention of absorption of the fluoride ion in cases of ingestion can be obtained by giving milk, chewable calcium carbonate tablets or milk of magnesia to conscious victims.

Protection of First Responders:

No action taken shall be taken involving any personal risk without suitable training. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation.

Section 6. Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation and inhalation of dusts and aerosols. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

For Emergency Responders: If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For Non-Emergency Personnel".

Methods for Containment

Large Spill: Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Section 7. Handling and Storage

Precautions:

Avoid formation and inhalation of dusts and aerosols. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Protective Measures:

Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid breathing dusts. Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

General Occupational Hygiene:

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Section 8. Exposure Controls/Personal Protection

Environmental Exposure Controls: Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

Individual Protection Measures

Hygiene Measures: Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not inhale dusts produced by product. Avoid contact with eyes and skin. Ensure that eyewash stations and safety showers are close to the workstation's location.

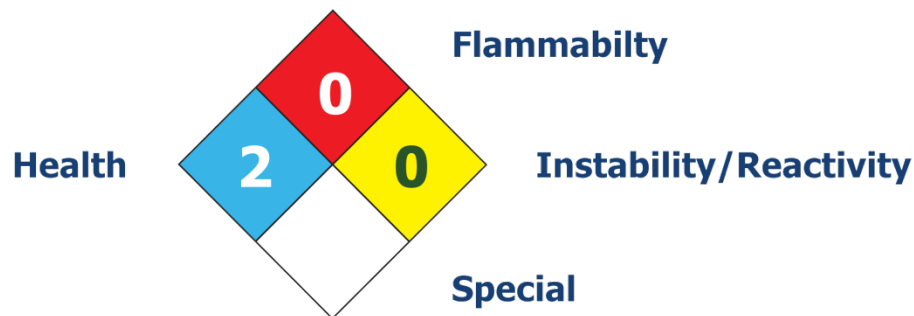
