### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

#### Methods for Containment

### Section 8. Exposure Controls/Personal Protection

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. #### Individual Protection Measures

##### Hygiene Measures:

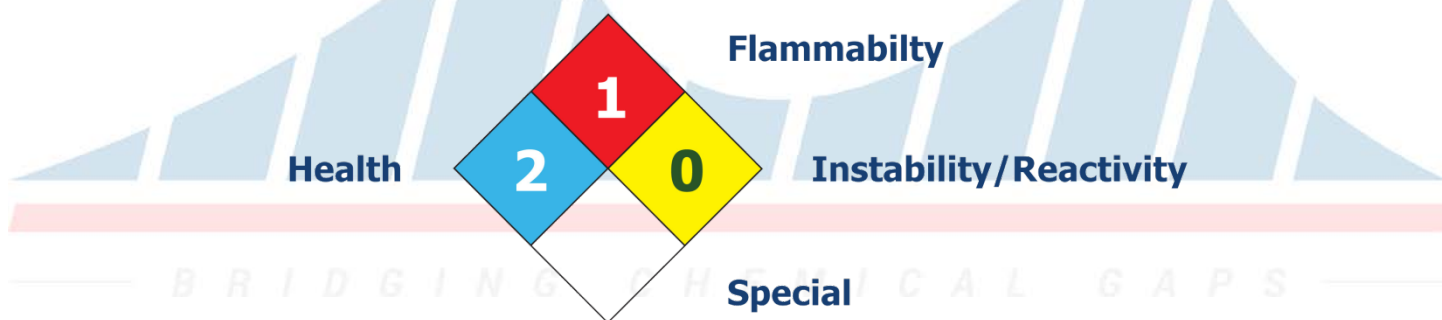
