Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. Consult a physician. Show this safety data sheet to the doctor in attendance.

Eye Contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing.

Skin Contact: Wash off contaminated skin with soap and plenty of water. Get medical attention if irritation develops and persists or if burns occur.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. Engineering Controls:	Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

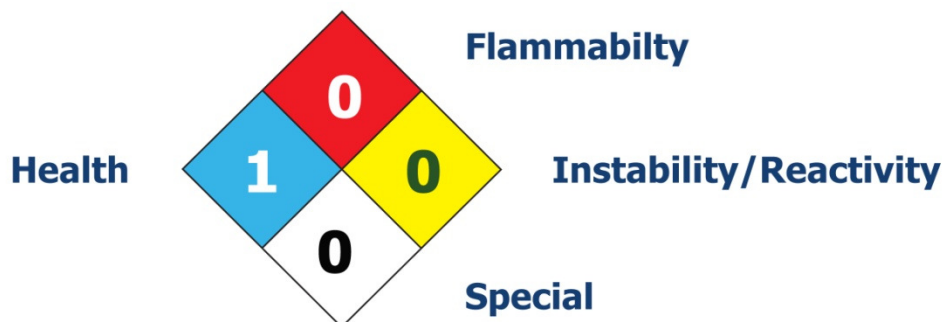
