Section 4. First Aid Measures

Description of Necessary First Aid Measures

- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used. CAUTION: REIGNITION MAY OCCUR.

Protection of Firefighters (cont.):

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel:

Environmental Precautions:

Methods for Containment

Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Avoid formation and inhalation of sprays and mists. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.
- Protective Measures:** Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Safe Storage Conditions:

Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Environmental Exposure Controls:

Hygiene Measures (cont.):

Eye/Face Protection:

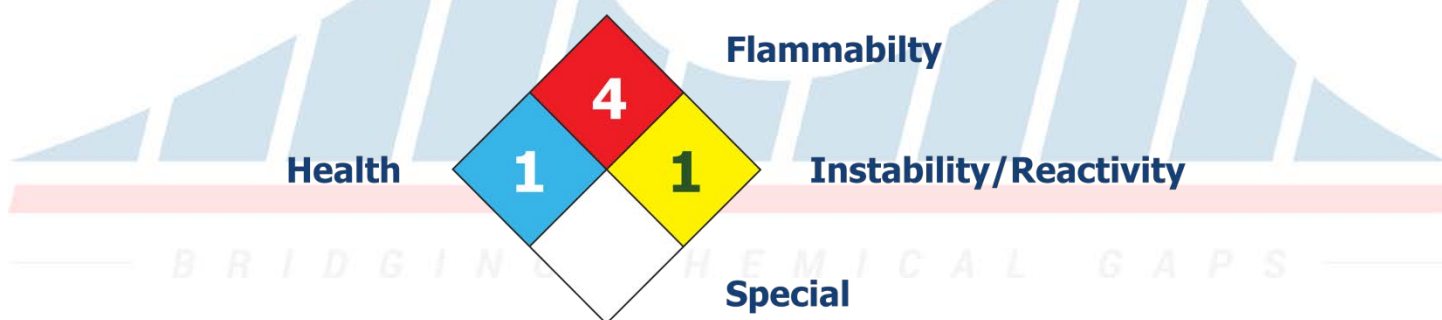
