### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical help immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

### Section 8. Exposure Controls/Personal Protection

#### Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.
