Section 4. First Aid Measures

Description of Necessary First Aid Measures

Section 7. Handling and Storage

Introductory Remarks:

These recommendations provide general guidance for handling this product. Individual Protection Measures

Hygiene Measures:

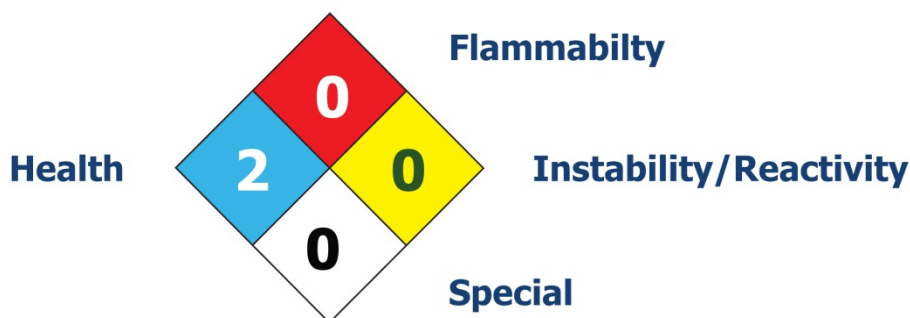
