### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

**General Advice:** Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

**Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process. Call a POISON CENTER or doctor/physician immediately.

**Skin Contact:** Remove all contaminated clothing and shoes. Wash off contaminated skin with soap and plenty of water. Call a POISON CENTER or doctor/physician immediately.

**Inhalation:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. ### Section 4. First Aid Measures

#### Most Important Symptoms/Effects, Acute and Delayed Potential Acute Health Effects

- Eye Contact:** Causes serious eye damage. Symptoms may include watering, redness, pain, swelling of the eyelids, inability to keep eye open, blurred vision and temporary/permanent loss of vision.
- Inhalation:** Product is extremely corrosive to mucous membranes and tissues of the upper respiratory tract. Symptoms may include a burning sensation, coughing, coughing up blood (hemoptysis), wheezing, laryngitis, shortness of breath/difficulty in breathing (dyspnea), blueness (cyanosis) of lips and skin, nausea, headaches, disorientation, general weakness and loss of consciousness.
- Skin Contact:** Skin contact with this product may be expected to cause (severe) chemical burns. Symptoms may include reddening of skin, a burning or itching sensation, pain, blistering and tissue necrosis.

### Section 5. Fire Fighting Measures

- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, soda ash, lime, dry chemical or carbon dioxide (CO<sub>2</sub>) may also be used. CAUTION: REIGNITION MAY OCCUR.

#### Unusual Fire and Explosion Hazards (cont.):

In case of fire, reignition of the product may occur after the fire has been extinguished. Product runoff to sewer may create a fire or explosion hazard. Vapors/gases released when product is exposed to moisture in air or water are heavier than air and will spread along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to an ignition source and flashback. Do not cut, grind, drill or weld on or near the container (even empty) of this product as an explosion may result. Keep away from heat, sparks and flame.

#### Product of Combustion:

Products of combustion include carbon oxides (CO<sub>x</sub>) and sodium oxides. Irritating fumes and organic acid vapors may be generated during exposure to elevated temperatures or open flame.

#### Protection of Firefighters:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid the formation and inhalation of dusts, aerosols, vapors and gases.

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters. Do not cut, grind, drill or weld on or near product containers (even empty) of this product because an explosion may result.

Fire-fighters should wear appropriate protection equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in a positive pressure mode.

#### Personal Precautions, Protective Equipment and Emergency Procedures

##### For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation and inhalation of dusts, aerosols, gases and vapors. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

### Section 6. Accidental Release Measures

**For Emergency Responders:** If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For Non-Emergency Personnel".

**Environmental Precautions:** Do not allow dispersal of spilled material and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

#### Methods for Containment

**General:** Spilled material will react rapidly to produce highly flammable gases when exposed to water and moisture in the air. Eliminate all local and distant ignition sources. Move containers from spill area if safe to do so. Avoid allowing the spilled material to get wet or using water to clean up spillages or residues. Use spark-proof tools and explosion-proof equipment.

**Small Spill:** Cover spillage with a dry, extinguishing material (e.g. sand, earth, soda ash, lime, vermiculite or diatomaceous earth) and allow time for decomposition or for fire to burn out. Collect and place spillage in a dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.

**Large Spill:** Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Cover spillage with a dry, extinguishing material (e.g. sand, earth, soda ash, lime, vermiculite or diatomaceous earth) and allow time for decomposition or for fire to burn out. Collect and place spillage in a dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

### Section 7. Handling and Storage

**Precautions:** Product reacts violently with moisture/water to release flammable gases which may ignite spontaneously; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended.

#### Precautions (cont.):

Keep away from all sources of ignition – NO SMOKING. Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

#### Protective Measures:

Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

#### General Occupational Hygiene:

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. See also Section 8 for additional information on hygiene measures.

#### Safe Storage Conditions:

Product reacts violently with moisture/water to release highly flammable gases which may ignite spontaneously; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store refrigerated at 2 – 8 °C. Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. ### Section 8. Exposure Controls/Personal Protection

#### Engineering Controls:

Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

#### Environmental Exposure Controls:

Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. In some cases, fume scrubbers, filters or engineering modifications to the process equipment will be necessary to reduce emissions to acceptable levels.

#### Individual Protection Measures

#### Hygiene Measures:

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not inhale fumes, aerosols or vapors. Avoid contact with eyes and skin. Ensure that eyewash stations and safety showers are close to the workstation location.

This product is stable when stored under a dry, inert atmosphere and away from heat. Nitrogen containing less than 5 ppm each moisture and air and a temperature range of 2 – 8 °C is recommended.

The user is referred to certain limited number of chemicals with recommended classifications in NFPA 49 and NFPA 325, which would be used as a guideline only.
