Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. Get emergency medical help immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical help immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

Eye Contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process.
