### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

#### Safe Storage Conditions:

Product is air/moisture sensitive; store under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store in original container protected from direct sunlight in a cool, dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

### Section 8. Exposure Controls/Personal Protection

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. 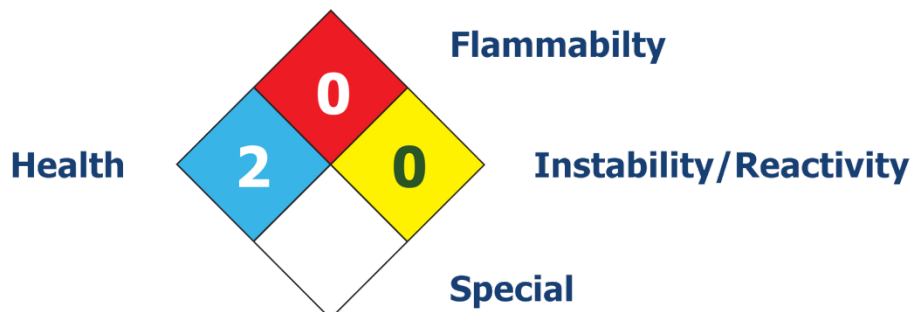
