Section 4. First Aid Measures

Description of Necessary First Aid Measures

Introductory Remarks: These recommendations provide general guidance for handling this product. 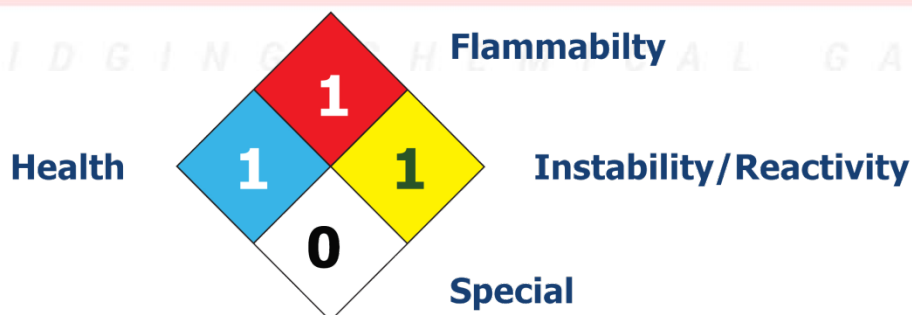
