### Section 4. First Aid Measures

**For Emergency Responders:**

### Section 7. Handling and Storage

**Precautions:**

Product is strongly hygroscopic; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

**Protective Measures:**

Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

### Section 7. Handling and Storage

- General Occupational Hygiene:** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking or smoking. Remove contaminated clothing and protective equipment before entering eating areas. - Safe Storage Conditions:** Product is strongly hygroscopic; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials noted above and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

### Section 8. Exposure Controls/Personal Protection

- Introductory Remarks:** These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. #### Hygiene Measures (cont.):

Ensure that eyewash stations and safety showers are close to the workstation location.

#### Eye/Face Protection:

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to dusts and aerosols. If contact is possible, the following protection should be worn, unless the assessment indicates a higher degree of protection: chemical splash goggles, faceshield (8-inch minimum). #### Skin Protection

#### Hand Protection:

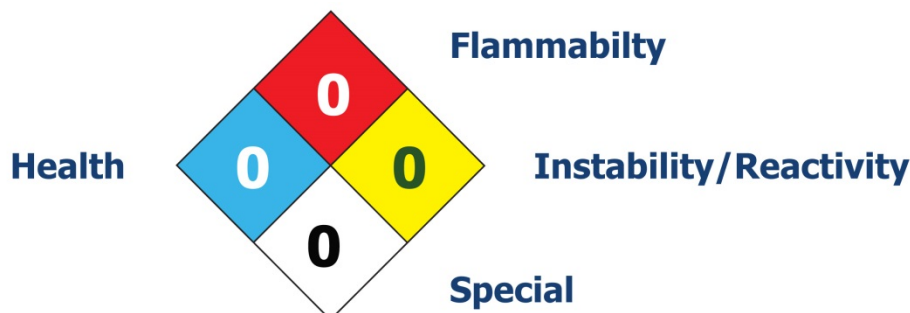
