Section 4. First Aid Measures

Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. If unconscious, place in recovery position and get medical help immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband. Show this safety data sheet to the doctor in attendance.
- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses if easy to do. Continue rinsing. Get medical help if eye irritation develops and persists.

Personal Precautions, Protective Equipment and Emergency Procedures

Introductory Remarks:

These recommendations provide general guidance for handling this product. 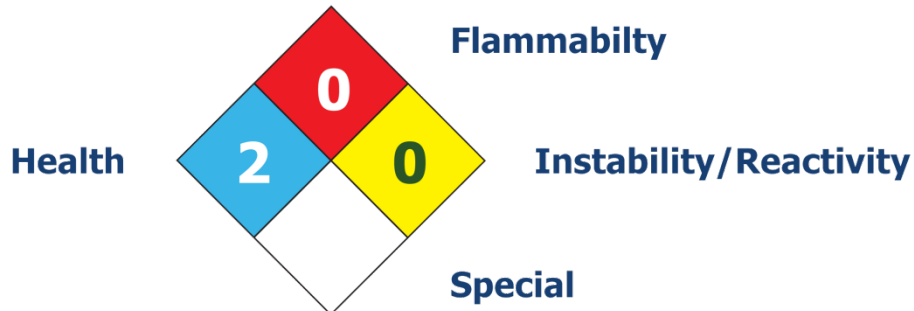
