Section 4. First Aid Measures

Description of Necessary First Aid Measures

General Advice: Move out of dangerous area. Call a POISON CENTER or doctor/physician immediately. Show this safety data sheet to the doctor in attendance. If unconscious, place in recovery position and get medical attention immediately. Maintain an open airway. Loosen tight clothing such as a collar, tie, belt or waistband.

Eye Contact: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Rinse for a minimum of 15 minutes. Check for and remove any contact lenses after initial rinse period and continue rinsing for an additional 15 minutes. Keep eyes wide open during rinsing process. Call a POISON CENTER or doctor/physician immediately.

Skin Contact: Remove all contaminated clothing and shoes. Wash off contaminated skin with soap and plenty of water. Call a POISON CENTER or doctor/physician immediately.

Inhalation: Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. It may be dangerous to the person providing aid to give mouth-to-mouth resuscitation. Call a POISON CENTER or doctor/physician immediately.

Ingestion: Do NOT induce vomiting. Rinse mouth. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by mouth to an unconscious person. Call a POISON CENTER or doctor/physician immediately.

Most Important Symptoms/Effects, Acute and Delayed Potential Acute Health Effects

Eye Contact: Symptoms may include stinging, tearing, redness, swelling and blurred vision.

Inhalation: Product is fatal if inhaled and may be irritating to mucous membranes and tissues of the upper respiratory tract. Symptoms may include a burning sensation, coughing, wheezing, laryngitis, shortness of breath/ difficulty in breathing (dyspnea), nausea and headaches.

Section 4. First Aid Measures

Skin Contact: Product is toxic in contact with the skin and may be expected to be irritating to the skin. Symptoms may include reddening of skin, a burning or itching sensation and pain.

Section 5. Fire Fighting Measures

Section 6. Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation of sprays, mists, vapors and gases. Do not breathe sprays, mists, vapors and gases. Provide adequate ventilation. Wear respiratory protection and appropriate personal protective equipment.

Methods for Containment

- Protective Measures:** Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

Individual Protection Measures

Hygiene Measures:

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not ingest or inhale sprays, mists, vapors or gases. Avoid contact with eyes and skin. Ensure that eyewash stations and safety showers are close to the workstation location.
