### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Get IMMEDIATE medical attention for any exposure to this compound. Show this safety data sheet to the doctor in attendance.

#### Individual Protection Measures

##### **Hygiene Measures:**

Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period. Remove all soiled and contaminated clothing immediately. Do not inhale dusts or aerosols. Avoid contact with eyes and skin. 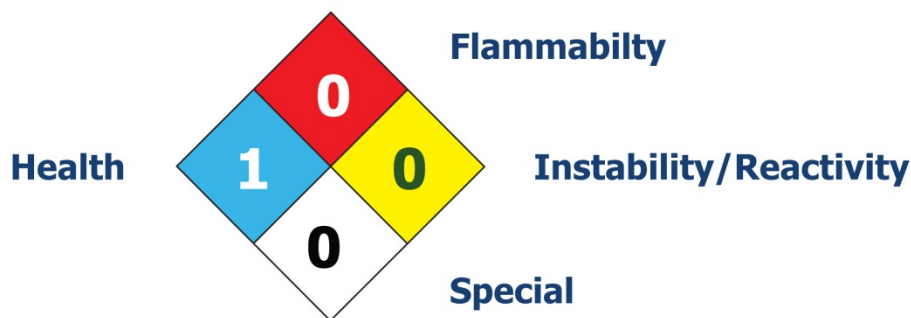
