#### Description of Necessary First Aid Measures

### Section 7. Handling and Storage

#### Precautions:

Product is air and moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation of aerosols and the inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

#### Protective Measures:

Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

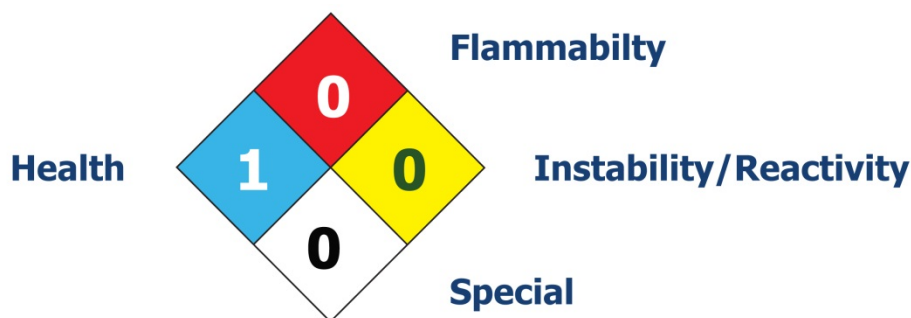
