Description of Necessary First Aid Measures

Ingestion: Rinse mouth. Do NOT induce vomiting. Remove dentures if any. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Most Important Symptoms/Effects, Acute And Delayed Potential Acute Health Effects

Eye Contact: The acute eye effects of this product have not been determined. However, severe chemical and thermal burns can occur and may cause permanent eye damage. Symptoms may include watering, redness, pain, blurred vision and temporary/permanent loss of vision.

Inhalation: Due to the products violent reactivity with water, inhalation of product may be expected to cause chemical and thermal burns of mucous membranes. Symptoms may include coughing, shortness of breath, difficulty in breathing, nausea and headaches.

Skin Contact: Skin contact with this product may be expected to cause severe chemical burns. Symptoms may include burning, itching, pain, redness, swelling and blistering with tissue necrosis.

Ingestion: Ingestion will result in burns of the mouth, throat, esophagus and digestive tract. Symptoms may include localized pain, cramps, nausea and vomiting.

Section 5. Fire Fighting Measures

Suitable Extinguishing Media: THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used.

Unusual Fire and Explosion Hazards (cont.):

Product runoff to sewer may create a fire or explosion hazard. Vapors and gases produced are heavier than air and will spread along the ground. Vapors may accumulate in low or confined areas or travel a considerable distance to an ignition source and flashback.

Product of Combustion:

Carbon oxides, nitrogen oxides (NO_x), tantalum oxides.

Protection of Firefighters:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid breathing dusts, aerosols, vapors and gases.

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters. To reduce the possibility of explosion, use a water spray or fog to reduce direct vapors and to cool unopened containers. Do not cut, grind, drill or weld on or near product containers (even empty) of this product because an explosion may result.

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid inhalation of sprays, mists, vapors and gases. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

For Emergency Responders:

Section 6. Accidental Release Measures

Methods for Containment

- General:** Eliminate all local and distant ignition sources. Move containers from spill area if safe to do so. Avoid allowing the spilled material to get wet or using water to clean up spillages or residues. Use spark-proof tools and explosion-proof equipment.
- Small Spill:** Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.
- Large Spill:** Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

Section 7. Handling and Storage

- Precautions:** Product is moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation and the inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.
- Protective Measures:** Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

Section 7. Handling and Storage

- General Occupational Hygiene:** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. Section 8. Exposure Controls/Personal Protection

- Introductory Remarks:** These recommendations provide general guidance for handling this product. Hygiene Measures (cont.):

Ensure that eyewash stations and safety showers are close to the workstation location.

Eye/Face Protection:

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts.
