Section 4. First Aid Measures

Description of Necessary First Aid Measures

- General Advice:** Move out of dangerous area. Call a physician or POISON CONTROL CENTER immediately. Show this safety data sheet to the doctor in attendance.
- Eye Contact:** Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Call a physician or POISON CONTROL CENTER immediately.
- Skin Contact:** Take off contaminated clothing and shoes immediately. Wash off contaminated skin with soap and plenty of water. Call a physician or POISON CONTROL CENTER immediately.

Most Important Symptoms/Effects, Acute And Delayed Potential Acute Health Effects

- Eye Contact:** The acute eye effects of this product have not been determined. However, severe chemical and thermal burns can occur and may cause permanent eye damage. Symptoms may include watering, redness, pain, swelling of the eyelids, inability to keep eye open, blurred vision and temporary/permanent loss of vision.
- Inhalation:** Product is extremely corrosive to mucous membranes and tissues of the upper respiratory tract. Symptoms may include a burning sensation, coughing, coughing up blood (hemoptysis), wheezing, laryngitis, shortness of breath/difficulty in breathing (dyspnea), blueness (cyanosis) of lips and skin, nausea, headaches, disorientation, general weakness and loss of consciousness.

- Skin Contact:** Skin contact with this product may be expected to cause severe chemical burns. Symptoms may include burning, itching, pain, redness, swelling and blistering with tissue necrosis.

Section 5. Fire Fighting Measures

- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used.
- Unsuitable Extinguishing Media:** DO NOT USE WATER OR FOAM as product reacts to produce extremely flammable vapors upon contact with water.
- Unusual Fire and Explosion Hazards:** This material reacts with water and compounds containing active hydrogen such as alcohols and acids to produce flammable liquids and gases. Protection of Firefighters (cont.):

Section 6. Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid inhalation of vapors, mists or gas. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

For Emergency Responders:

If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For nonemergency personnel".

Environmental Precautions:

Do not allow dispersal of spilled material and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

Methods for Containment

General:

Section 6. Accidental Release Measures

Small Spill:

Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.

Large Spill:

Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry absorbent material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Section 7. Handling and Storage

Precautions:

Product is moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Avoid the formation of aerosols and the inhalation of sprays, mists, vapors and gases. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Protective Measures:

Protect against electrostatic charges. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.

General Occupational Hygiene:

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Section 7. Handling and Storage

Safe Storage Conditions:

Product is moisture sensitive; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store refrigerated at 2 – 8 °C. Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials noted above and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

Section 8. Exposure Controls/Personal Protection

Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. While developing safe handling procedures, do not overlook the need to clean equipment and conduct regular repairs. Waste from these procedures should be handled in accordance with Section 13.

Section 8. Exposure Controls/Personal Protection

Eye/Face Protection:

Safety eyewear complying with an approved standard should be used when a risk assessment indicates this is necessary to avoid exposure to liquid splashes, mists, gases or dusts.
