#### Methods for Containment

##### **General:**

Stop spillage and move unopened containers from spill area if safe to do so. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Dusts from product should be treated as flammable; eliminate all local and distant ignition sources. Take action to prevent static discharges. ### Section 8. Exposure Controls/Personal Protection

#### Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application.
