Section 5. Fire Fighting Measures

General Hazards: Pyrophoric liquid. Product catches fire spontaneously when exposed to air. Product reacts violently with water.

Suitable Extinguishing Media: THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO₂) may also be used.

Unsuitable Extinguishing Media: Water.

Unusual Fire and Explosion Hazards: Product reacts with air and water to produce flammable liquids and gases. Product runoff to sewer may create a fire or explosion hazard. Section 5. Fire Fighting Measures

Protection of Firefighters:

Promptly isolate the scene by removing all persons from the vicinity of the incident if there is a fire. No action shall be taken involving any personal risk or without suitable training. Avoid contact with skin or eyes. Avoid breathing dusts, aerosols, vapors and gases.

Section 6. Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures

For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation and inhalation of sprays and mists. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

For Emergency Responders:

Environmental Precautions:

Section 6. Accidental Release Measures

- Small Spill:** Contain and collect spillage with a dry, non-combustible binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in a dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.
- Large Spill:** Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. - Precautions:** Product is air/water sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Avoid formation and inhalation of sprays and mists. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

Section 7. Handling and Storage

Safe Storage Conditions:

Product is air/water sensitive; store under an inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Store refrigerated at 2 – 8 °C. Keep away from all sources of ignition – NO SMOKING. Store in original container protected from direct sunlight in a dry and well-ventilated area, away from incompatible materials and food and drink. Keep container tightly closed and sealed until ready for use. Store locked up.

Section 8. Exposure Controls/Personal Protection

Introductory Remarks:

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application.
