Description of Necessary First Aid Measures

Section 6. Accidental Release Measures

Large Spill:

Eliminate all ignition sources. Move containers from spill area if safe to do so. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Engineering Controls: Properly operating explosion-proof, chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.

Eye/Face Protection:
