### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

<b>General Advice:</b>	Move out of dangerous area. Consult a physician. Show this safety data sheet to the doctor in attendance.
<b>Eye Contact:</b>	Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue rinsing. Get medical attention if eye irritation develops and persists.
<b>Skin Contact:</b>	Wash off contaminated skin with soap and plenty of water. Get medical attention if irritation develops and persists or if burns occur.

### Section 5. Fire Fighting Measures

- General Hazards:** Reacts with water to produce a flammable liquid/gas.
- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO<sub>2</sub>) may also be used.

#### Protection of Firefighters (cont.):

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters. To reduce the possibility of explosion, use a water spray or fog to reduce direct vapors and to cool unopened containers. Do not cut, grind, drill or weld on or near product containers (even empty) of this product because an explosion may result.

##### For Emergency Responders:

##### Environmental Precautions:

#### Methods for Containment

##### General:

Eliminate all local and distant ignition sources. Move containers from spill area if safe to do so. Avoid allowing the spilled material to get wet or using water to clean up spillages or residues. Use spark-proof tools and explosion-proof equipment.

##### Small Spill:

### Section 6. Accidental Release Measures

#### Large Spill:

Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with non-combustible, dry binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). ### Section 7. Handling and Storage

#### Precautions:

Avoid formation and inhalation of dusts and aerosols. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.

#### Protective Measures:

Protect against electrostatic charges. Fumes can combine with air to form an explosive mixture. Use explosion-proof electrical/ventilating/lighting/handling equipment. Use only non-sparking tools and equipment. Put on appropriate personal protective equipment (see Section 8). Do not ingest. Avoid contact with eyes, skin and clothing. Avoid the formation and inhalation of dusts, vapors or aerosols. Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. **Engineering Controls:** Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.
