Section 5. Fire Fighting Measures

Unusual Fire and Explosion Hazards:

This material reacts with water and compounds containing active hydrogen such as alcohols and acids to produce flammable liquids and gases. Product runoff to sewer may create a fire or explosion hazard. Most vapors and gases produced under fire conditions are heavier than air and will spread along the ground. Section 6. Accidental Release Measures

Environmental Precautions:

Methods for Containment
