Description of Necessary First Aid Measures

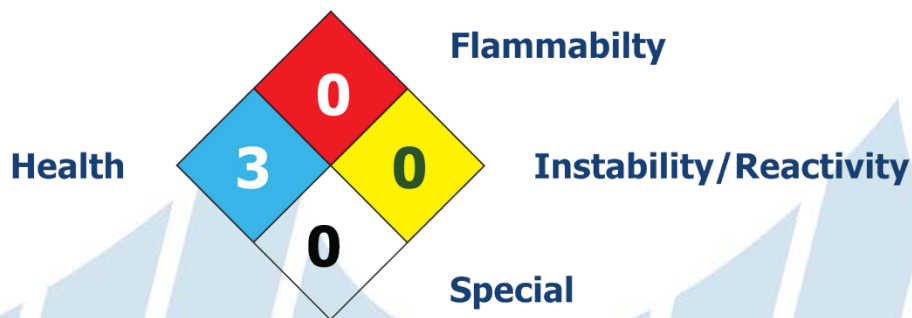
