#### Description of Necessary First Aid Measures

**Introductory Remarks:** These recommendations provide general guidance for handling this product. 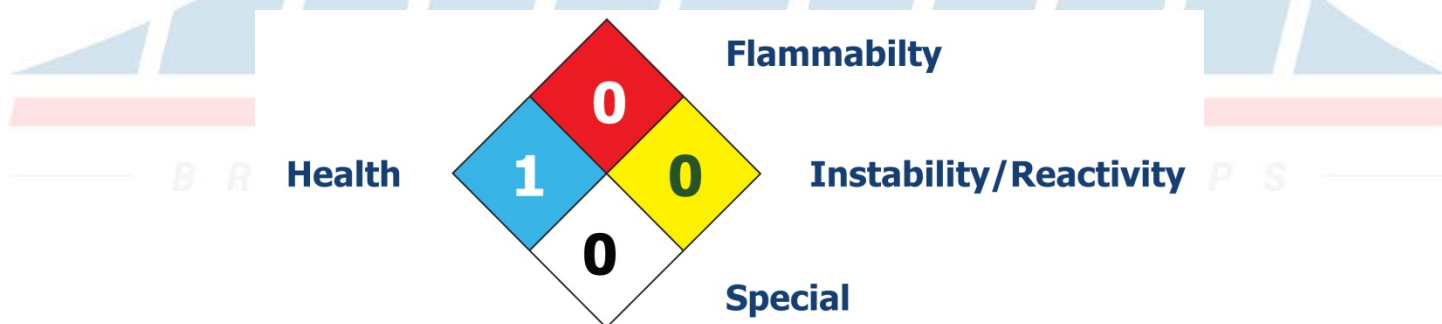
