### Section 4. First Aid Measures

#### Description of Necessary First Aid Measures

### Section 5. Fire Fighting Measures

- General Hazards:** Product reacts violently with water to produce a highly flammable liquid and gas.
- Suitable Extinguishing Media:** THE MOST EFFECTIVE FIRE EXTINGUISHING AGENT IS DRY CHEMICAL POWDER PRESSURIZED WITH NITROGEN. Vermiculite, sand, dry chemical or carbon dioxide (CO<sub>2</sub>) may also be used.
- Unsuitable Extinguishing Media:** DO NOT USE WATER OR FOAM as product reacts to produce extremely flammable vapors upon contact with water.

#### Protection of Firefighters (cont.):

Avoid contact with skin or eyes. Avoid the formation and inhalation of dusts, aerosols, vapors and gases.

Eliminate all local and distant ignition sources. Move containers from fire area if process can be accomplished without risk to firefighters. To reduce the possibility of explosion, use a water spray or fog to reduce direct vapors and to cool unopened containers.

Fire-fighters should wear appropriate protection equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in a positive pressure mode.

### Section 6. Accidental Release Measures

#### Personal Precautions, Protective Equipment and Emergency Procedures

##### For Non-Emergency Personnel:

No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Provide adequate ventilation. Wear respiratory protection. Put on appropriate personal protective equipment.

##### For Emergency Responders:

If specialized clothing is required to deal with the spillage, take note of any information in Section 8 on suitable and unsuitable materials. See also the information in "For Non-Emergency Personnel".

##### Environmental Precautions:

#### Methods for Containment

##### General:

Spilled material will likely give off smoke and fumes. Ignition may occur immediately. Eliminate all local and distant ignition sources. Move containers from spill area if safe to do so. ### Section 6. Accidental Release Measures

- Small Spill:** Contain and collect spillage with a dry, non-combustible binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor.
- Large Spill:** Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Contain and collect spillage with a dry, non-combustible binding material (e.g. sand, earth, vermiculite or diatomaceous earth) and place in dry, sealed container for disposal according to local regulations (see Section 13). Dispose of via a licensed waste disposal contractor. Contaminated absorbent material may pose the same hazard as the spilled product.

### Section 7. Handling and Storage

- Precautions:** Product is air/moisture sensitive; handle under a dry, inert gas. Nitrogen with less than 5 ppm each of moisture and oxygen is recommended. Keep away from all sources of ignition – NO SMOKING. Avoid the formation and inhalation of dusts, aerosols, vapors and gases. Keep container tightly sealed. Avoid contact with skin, eyes and clothing. Do not ingest. Avoid prolonged exposure. Ensure adequate ventilation.
- Protective Measures:** Put on appropriate personal protective equipment (see Section 8). Keep in the original container kept tightly closed when not in use. Empty containers retain product residue and can be hazardous. Do not reuse container.
- General Occupational Hygiene:** Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking. Remove contaminated clothing and protective equipment before entering eating areas. ### Section 8. Exposure Controls/Personal Protection

#### **Introductory Remarks:**

These recommendations provide general guidance for handling this product. Because work environments and material handling practices vary, safety procedures should be developed for each intended application. ##### **Hygiene Measures:**
